TUSCALOOSA VA MEDICAL CENTER

The Tuscaloosa VA Medical Center (TVAMC) is located on a beautiful campus of 125 acres in Tuscaloosa, Alabama. The Medical Center provides primary care, long-term health care, and mental health care services to eligible veterans. The Outpatient Services in Primary Care provides services to thousands of patients each year. Clinical Pharmacists are extensively involved in the Primary Care Clinics to help manage anticoagulation, diabetes mellitus, hyperlipidemia, hypertension, and other disease states. Clinical Pharmacists are also involved in inpatient and outpatient mental health, long term care, and home based primary care.

- Possess skills which will enable them to pursue a variety of career interests requiring pharmacological expertise.
