The PGY2 Pain Management and Palliative Care Pharmacy Residency at the San Francisco VA Health Care System is a one-year specialty residency designed to prepare a pharmacist to practice as a pain management, palliative care and/or substance use disorder Clinical Pharmacy Practitioner. The residency program includes training alongside a variety of multidisciplinary pain management, addiction medicine, and palliative care teams. This residency affords direct patient care opportunities within the inpatient, perioperative, and ambulatory care settings.

## **Application Requirements**

- United States citizen
- Earned Doctor of Pharmacy from accredited college of pharmacy
- Completion or anticipated completion of an ASHP accredite (or candidate status) PGY1 residency program
- Must submit application materials through PhORCAS

## **Application Materials | PhORCAS**

- Official college of pharmacy transcripts
- Letter of intent (no longer than 2 pages, minimum 11 font and 1 inch margins) should address:
  - 1. What interests you in pursuing pain management and palliative care specialty?
  - 2. Why you are interested in this program?
  - 3. How do expect this program to help you achieve your short-term and long-term goals?
  - 4. A significant challenge that you encountered in your academic, personal, or professional career to date.
- Current curriculum vitae should include details of rotation activities, including future rotations, and any teaching or community service activities.
- At least 3 letters of recommendation- at least one letter must be from a preceptor with whom you have had a clinical rotation.

## Application deadline: January 2, 2024

## Appointment of Applicants

Applicants must meet requirements for federal appointment.

Appointment is contingent upon satisfactory completion of a physical exam, including a negative drug test. This residency site agrees that no person at this site will solicit, accept, or use any ranking-related information from any residency applicant.
