

# PGY2 RESIDENCY PROGRAMS

#### **PURPOSE STATEMENT:**

PGY2 pharmacy residency programs build on Doctor of Pharmacy (Pharm.D.) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

## **STAFFING AND/OR PER DIEM**

**REQUIRED** "Staffing" or "Service" components as designated by specialty program

**OPTIONAL** opportunities to work per diem inpatient or outpatient at VASD in *ADDITION* to rotation hours. Per diem is NOT guaranteed and restrictions may be placed on number of hours (case-by-case basis)

## PHARMACIST LICENSE REQUIREMENT

The resident must be licensed in any of the 50 states to practice as a pharmacist at VA San Diego Healthcare System within 120 days from the first day of their residency program. Noncompliance will result in termination from the program.

### **RESIDENT PRECEPTING PROGRAM**

- Our pharmacy residents participate in the teaching of approximately 30 Doctor of Pharmacy students from the University of the Pacific and University of California, San Diego Schools of Pharmacy
- Pharmacy Residents serve as a preceptor to APPE students during rotations by providing formal and informal teaching and mentoring
- Residents facilitate weekly conferences consisting of topic discussions and clinical case presentations

#### **TEACHING CERTIFICATE PROGRAM**

- All pharmacy residents may participate in a Skill Development Series, which includes regularly scheduled discussion of research-related topics such as study methodology, biostatistics, literature evaluation, individual residency research projects and other contemporary topics relevant to health care professionals
- Teaching Certificate Program through the San Diego Pharmacy Residency Leaders Program (SDPRL) is offered to all pharmacy residents (optional for PGY2s) and consists of didactic seminars and assignments, development of a personal teaching philosophy and providing formal teaching experiences in clinical rotational settings

# PGY2 Ambulatory Care

#### **Program Overview:**

Our PGY-2 Ambulatory Care Residency program can be tailored to one's interests and is devoted to developing the skills and clinical expertise needed for the delivery of patient-centered care. Our clinical pharmacy specialists (CPS) possess scopes of practice to provide comprehensive medication management (CMM) to veterans seen in Primary Care and specialty clinics.

Upon completion of this program, graduates will be competent to pass the Board Certification in Ambulatory Care and be capable of obtaining employment with prescriptive authority to provide collaborative drug therapy management to adult and geriatric patients. Graduates will be proficient in providing the following services:

- Provide a high level of effective, efficient, evidence-based patient-centered care for chronic diseases encountered in Primary and Specialty Care Clinics
- Demonstrate excellence as educators/mentors/preceptors to pharmacy trainees and other health-care professionals
- Demonstrate leadership and practice management skills
- Promote health improvement, wellness, and disease prevention and serve as the ultimate resource on optimal prescribing of medications

#### **Service Commitment:**

Residents will staff 1 day per week in the Outpatient Pharmacy. Additional staffing responsibilities vary depending on the elective learning experiences.

#### **Facilities:**

The resident office is located at the VA Medical Center in La Jolla, California and most activities will occur at this site. However, travel is required to the surrounding Community Based Outpatient Clinics (CBOCs) within San Diego County.

# PGY2 Critical Care Pharmacy

**ASHP Code: 92367 NMS Code: 609052** 

#### **Program Overview:**

• This residency is designed for graduates to develop the skills and confidence necessary to practice as a critical care pharmacist specialist and be eligible for board certification. Residents will become an integrated member of an interdisciplinary team to provide comprehensive medication management in pulmonary, cardiology, emergency medicine, and surgical services. Responsibilities include direct patient care, teaching health professionals/trainees, and completing a research project related to the critical care environment.

#### **Educational Goals:**

- In collaboration with the health care team, provide comprehensive medication management to critically ill patients following a consistent patient care process
- Demonstrate ability to manage formulary and medication-use processes for critically ill patients, as applicable to the organization
- Demonstrate leadership skills for successful self-development in the provision of care for critically ill patients
- Provide effective medication and practice-related education to critically ill patients, caregivers, health care professionals, students, and the public (individuals and groups)
- Demonstrate the skills necessary to conduct a critical care pharmacy research project

# PGY2 Psychiatric Pharmacy

#### **Program Overview:**

Our PGY2 residency program in psychiatry is designed to foster competency in the area of clinical psychiatric
pharmacotherapy. Residents develop advanced clinical skills through hands-on participation in ambulatory and
acute care rotations. Selected core experiences include direct patient care responsibilities in an acute inpatient
general psychiatry unit, ambulatory care mental health medication management clinics, residential/domiciliary
programs, and an inter-professional consult liaison service. One elective rotation can be chosen based on
the resident's interests. Most of our psychiatric pharmacists possess Scopes of Practice that allow them to practice
independently as mid-level healthcare providers. Graduates of our program are trained to become knowledgeable,
well-rounded psychiatric pharmacy specialists.

#### **Learning Objectives:**

Upon successful completion of the program, the resident will be able to:

- Serve as an authoritative resource on optimal medication use in individuals with neuropsychiatric disorders
- Optimize outcomes for patients with a variety of psychiatric and neuropsychiatric disorders by providing evidencebased, patient-centered medication therapy as an integral member of multidisciplinary treatment teams
- Evaluate and improve the medication-use process in psychiatric and neuropsychiatric patient care areas
- Conduct psychiatric pharmacy practice and outcomes research
- Serve as a psychiatric pharmacy preceptor for advanced pharmacy practice experiences and PGY1 residents
- Obtain board certification in psychiatric pharmacy (BCPP)

# PGY2 Health-System Pharmacy Administration & Leadership

#### **Program Overview:**

• This specialty residency is designed to prepare a pharmacy practitioner for an operational management/supervisory role in a variety of work settings. This residency lays a strong foundation for continued growth in management and leadership skills with the expectation that with several years of successful pharmacy administration practice, the residency graduate should be ready to assume high-level managerial, supervisory, and leadership responsibilities of a large hospital or health-system pharmacy.

#### **Program Description:**

• This is a twelve-month postgraduate year two program that provides training and experience in Health System Pharmacy Administration. Pharmacists completing this PGY2 specialty residency will build off their PGY1 residency competencies in the delivery of patient-centered care and pharmacy operational services.

#### **Learning Objectives:**

- Develop an understanding of the principles of administration and leadership in a highly innovative integrated healthcare system.
- Develop an understanding and competency in managing and leading a large complex pharmacy organization
- Develop skills in research design and data analysis to assess pharmaceutical-related economic, clinical, and humanistic health outcomes.

 The resident office will be located at the VA Medical Center in La Jolla, California and most activities will be coordinated from this site.

# PGY2 Pharmacy Informatics

ASHP Code: 92018 NMS Code: 627674

#### **Program Overview:**

• This PGY2 Pharmacy Informatics residency will provide the skills necessary for the practical application of pharmacy informatics and automated technology assessment principles in integrated healthcare systems. The resident will be involved with every aspect in the management of pharmacy data applications, data support and analysis for pharmacy and medical center leadership, pharmacy technology assessment, implementation, and maintenance. The resident will gain experience with Computerized Patient Record System (CPRS), Computerized Prescriber Order Entry (CPOE), Barcode Medication Administration (BCMA), medication storage and retrieval devices (Omnicell®), and medication dispensing robotics (ScriptPro®). Other responsibilities include conducting outcomes research and precepting pharmacy trainees (students and residents) with informatics related projects. Education will include formal informatics training and hands-on application of principles. Work activities will encompass the VASDHS, and experiential rotations on a regional/national level. Out-of-state and in-state travel may be required.

#### **Learning Objectives**

- Develop an understanding of the principles of the use of pharmacy informatics in an integrated healthcare system
- Develop an understanding of healthcare technology development, evaluation, implementation, and maintenance at local, regional, and national levels
- Develop skills in research design and data analysis to assess pharmaceutical-related economic, clinical, and humanistic health outcomes
- Develop skills in project management and strengthen communication skills for effective collaboration with the multidisciplinary team
- Develop an understanding of the role of pharmacy informatics in medication safety to assist in quality improvement

# PGY2 Oncology Pharmacy

ASHP Code: 92361 NMS Code: 601460

#### **Program Overview:**

• This PGY2 Oncology Pharmacy Residency training program is designed to develop clinical competency as a Clinical Pharmacy Specialist in the area of oncologic pharmacotherapy. Our clinically based program offers ongoing inpatient and outpatient longitudinal experiences devoted to the development of skills essential for the delivery of pharmaceutical care with a primary focus on oncology. To augment the VA experience, the resident may train off site in the areas of bone marrow transplant, gynecologic cancers, and pediatric oncology. In addition, the resident will be able to achieve optimal drug therapy outcomes and formulary management as active members of the health care team. The resident will be able to serve as a competent oncology rotation preceptor of 4th year pharmacy and PGY1 Pharmacy Practice Residents in their Oncology Pharmacy Practice Experience elective rotations. Lastly, the resident will be able to exercise proficiency in communication and in educating other health care professionals, patients, and the community on drug related topics in oncology. Graduates of this 12-month training program should be able to provide a high level of direct patient care, ultimately leading to competence commensurate with Board Certification in Oncology Pharmacy Practice by the Board of Pharmaceutical Specialties and obtain employment as a Clinical Pharmacy Specialist in Oncology.

- Develop an understanding of the principles of prevention and management of chemotherapy-related toxicities
- Develop skills in research design and methodologies to assess pharmaceutical-related economic, clinical, and humanistic health outcomes

## **PGY2 Infectious Diseases**

#### **Program Overview:**

This specialty residency program is designed to provide our residents with the skills necessary to become a
competent and confident practitioner of pharmaceutical care in a variety of infectious diseases practice settings.
After program completion, residents will possess the skills needed to work in ambulatory care, inpatient clinical
positions, academia, and pharmaceutical industry.

#### **Learning Objectives:**

- · Promote health improvement, wellness, and the prevention of infectious diseases
- Optimize patient outcomes by providing evidence-based, patient-centered medication therapy as an integral member of an interdisciplinary infectious diseases team
- Manage and improve the medication-use process in infectious diseases patient care
- Demonstrate excellence in the provision of educational activities on optimizing anti-infective pharmacotherapy for health care professionals and trainees
- Serve as an authoritative resource on the optimal use of medications used to treat individuals with an infectious disease
- Demonstrate leadership and practice management skills
- Conduct infectious diseases pharmacy practice research
- Demonstrate skills required for managing and improving anti-infective-use processes

#### **Facilities:**
