

# PGY-1 Pharmacy Residency Overview

The Bay Pines VAHCS is a non-profit, teaching medical facility located on 337 acres situated on the Gulf of Mexico. The healthcare system serves a 10 county area from Pinellas County in the north to Collier County in the south. Together, the Bay Pines VAHCS provides care to over 110,000 Veterans every year including our outpatient clinics in Bradenton, Lee County, Naples, Palm Harbor, Port Charlotte, St. Petersburg, Sarasota, and Sebring. Our healthcare system serves the healthcare needs of America's Veterans in West Central and Southwest Coastal Florida by providing primary care, specialized care, and related medical and social support sources.

The PGY-1 residency program is accredited by the American Society of Health-System Pharmacists. The residents will develop competency in the areas of acute patient care, ambulatory/primary care, drug information, practice management, and pharmacy operations. The focus of this residency is to develop residents into competent clinical practitioners who will contribute to positive patient outcomes. The residents will have responsibility and will be directly involved in providing patient oriented pharmaceutical services. The residents will develop knowledge and skills required to become a competent, clinical practitioner through training in various areas of pharmacy practices.

#### **Application Requirements**

- The applicant must possess a Doctor of Pharmacy Degree (Pharm.D.) from an ACPE accredited college
- U.S. citizenship is required
- The applicant must be registered with the American Society of Health-System Pharmacists' Match Program
- An interview is required for all invited applicants
- Application materials must be submitted by January 2, 2023
- Complete online application through PhORCAS
  - Transcripts
  - Curriculum Vitae
  - Letter of Intent
  - Reference Letters (3)

- Applicants will be evaluated according to specific criteria using established rubrics by the residency committee and will be contacted for a virtual interview (tentative)

Dr. Aimee Jensen is the director of the PGY1 Pharmacy Residency Program at the Bay Pines Main Campus and is a Clinical Pharmacy Specialist in Mental Health. Dr. Jensen received her Bachelors of Science from University of Florida before going on to Auburn University where she graduated with honors with a Doctorate in Pharmacy. Dr. Jensen completed both her PGY-1 Pharmacy Practice Residency and PGY-2 Psychiatric Pharmacy Residency at the VA Tennessee Valley Healthcare System. Dr. Jensen became a Board-Certified Pharmacotherapy Specialist in 2017, and a Board-Certified Psychiatric Pharmacist in 2018. She currently practices in the Mental Health Residential Rehabilitation Treatment Program (MHRRTP) where she works primarily with Veterans with warrelated Post Traumatic Stress Disorder (PTSD) and those with a history of sexual trauma that occurred during military service (MST or Military Sexual Trauma).

Dr. Carolyn Combs is the Residency Coordinator, Pharmacy Compliance Program Manager, and a Clinical Pharmacy Supervisor at the CW "Bill" Young VA Medical Center. Dr. Combs received her Doctor of Pharmacy degree from East Tennessee State University, Gatton College of Pharmacy in 2013. After graduating, she completed a PGY-1 residency at the VA Medical Center in Lexington, Kentucky. She subsequently completed her PGY-2 Health Systems Pharmacy Administration Residency at the Bay Pines VAHCS. She is involved in several local, regional, and national committees which focus on pharmacy education, medication safety, and compliance. Dr. Combs works closely with all pharmacy residents, precepting a required rotation for PGY1s in Patient Safety, and is the supervisor for all pharmacy trainees.

# **Description of Offered Rotations**

#### Orientation Type: Required Block

Preceptor(s): Aimee Jensen, PharmD, BCPS, BCPP; Carolyn Combs, PharmD, MBA, BCPS

Description: The purpose of this learning experience is to orient PGY1 pharmacy residents to the Bay Pines VA Health Care System, review residency program requirements and expectations, and provide residents with knowledge, skills and abilities to be successful during both the residency program and their future professional careers. The learning experience is a total of 5 weeks, with the first two weeks comprised of orientation and introductory sessions and the remaining 3 weeks comprised of practice in operations and other clinical areas. After the initial two weeks of orientation sessions, residents will rotate through various areas of the health care system based on individual schedules. They will participate in training activities including an introduction to medication reconciliation, pharmacy operations, discharge or transitional care, priorauthorization/non-formulary drug review, and medication safety/medication use systems. They will be trained to enter progress notes in the patient chart and document interventions for workload capture. They will begin training for VISTA order entry and will be granted pharmacist verification permissions once licensed. During this experience, pharmacy residents will also attend conferences for professional development (time management, project preparation sessions, etc.).

#### Internal Medicine

#### Type: Required Block

<u>Description</u>: The acute care clinical pharmacy specialist (CPS) works within those interdisciplinary teams and is responsible for parenteral nutrition management, pharmacokinetic management, transitions of care for ambulatory care sensitive conditions, renal dosing, therapeutic drug monitoring, antimicrobial stewardship, IV to PO conversions, inpatient formulary management, and various other clinical interventions.

#### Ambulatory Care

#### Type: Required Block

<u>Preceptor(s)</u>: Amanda Atherton, PharmD; Gigi Thomas, PharmD; Michael Kelley, PharmD; Rodrique Rodney, PharmD, BCACP, CDE; Brian Steele, PharmD, BCPS; Megan Martinez, PharmD; Jennifer Ngo, PharmD

<u>Description</u>: This learning experience is conducted in physician referral driven clinics that are managed by clinical pharmacy specialists (CPS). The CPS in primary care is responsible for managing chronic diseases including but not limited to hypertension, hyperlipidemia, congestive heart failure, diabetes, hypothyroidism and vascular disorders that warrant anticoagulation.

#### Patient Safety/Pharmacy Benefits Management/Preceptorship

#### Type: Required Block

Preceptor(s): Carolyn Combs, PharmD, MBA, BCPS; Quynh-Nhu Truong, PharmD, BCPS

<u>Description</u>: This is a three part rotation as indicated by the title. The purpose of the Pharmacy Benefits Management rotation is to involve the resident in the drug formulary process, management of appropriate medication use, medication safety issues, and medication cost savings initiatives. The preceptorship portion of the rotation is designed to enhance the resident's skills by precepting pharmacy students utilizing the four preceptor roles (instruction, modeling, coaching, and facilitating) of practice-based teaching. The patient safety portion of the rotation will include participation in P&T, reviewing reported patient safety events, and updating policies as needed.

#### Acute Care: Emergency Department

Type: Selected Required Block or Elective

Preceptor(s): Mary Hall, PharmD, BCPS

<u>Description:</u> Residents will gain experience optimizing medication therapy regimens, expediting access to medications, providing drug information, facilitating proper medication use during emergency procedures, and interviewing patients for medication reconciliation purposes to patients in the Emergency Department. The resident will work as a member of the interdisciplinary medical team by providing medication recommendations, responding to drug information requests, facilitating expedient access to medications as directed by the preceptor and offering pharmacy support to optimize patient care.

#### Acute Care: Critical Care

#### <u>Type:</u> Selected Required Block or Elective

#### Preceptor(s): Victor Rozance, PharmD

<u>Description:</u> Residents in the intensive care unit will gain experience providing pharmacokinetic monitoring of selected pharmaceuticals, evaluating patient specific lab parameters, participating in daily SICU and MICU interdisciplinary rounds, evaluating pharmacotherapy for drug related problems, providing antimicrobial stewardship interventions, evaluating appropriateness of pain management and sedation, identifying and resolving drug interactions, managing formulary and cost mitigation strategies, managing time, responding to drug information questions, supervising pharmacy students (as available), and other pharmacy related practice tasks.

#### Mental Health: Inpatient Psychiatry

#### Type: Selected Required Block or Elective

<u>Preceptor(s)</u>: Michele Summerville, PharmD, BCPP

<u>Description:</u> The Inpatient Mental Health units function as an acute stabilization unit to assist Veterans experiencing psychiatric crisis. The interdisciplinary team consists of psychiatrist, primary care providers, pharmacy, psychology, social work, nursing, and recreational therapy. There are at total of 33 inpatient beds divided between two inpatient Mental Health units. A variety of psychiatric disease states are seen on the inpatient units such as schizophrenia, bipolar disorder, depression, substance use disorders, PTSD, and more. During this rotation, the resident will work with the inpatient psychiatry team to provide Veterans with optimal psychotropic medications during their admission. They will gain experiences with rounding with psychiatric providers, patient interviews, leading medication education groups, and enhancing their knowledge of psychiatric disease states and medications

#### Mental Health: PTSD Residential Treatment

Type: Selected Required Block or Elective

Preceptor(s): Aimee Jensen, PharmD, BCPS, BCPP

<u>Description</u>: Mental Health Residential Treatment Program (MHRRTP) provides residential level of care through a voluntary inpatient admission for patients to receive intensive treatment. The focus of this rotation is on the treatment of PTSD following combat related trauma and/or military sexual trauma. In addition to PTSD, Veterans often present with co-occurring mental health disorders such as depression, insomnia, and substance use disorders.

#### Mental Health: Substance Use Disorder Residential Treatment

Type: Selected Required Block or Elective

Preceptor(s): Meghan Duquette, PharmD, BCPS, BCPP

<u>Description:</u> Mental Health Residential Treatment Program (MHRRTP) provides residential level of care through a voluntary inpatient admission for patients to receive intensive treatment. The focus of this rotation is on the treatment of substance use disorders (SUD) and co-occurring mental health disorders, including depression, anxiety, insomnia, and PTSD. Alcohol use disorder and stimulant use disorders (cocaine/crack cocaine) are the most common admitting diagnoses, however SUD of all kinds, including opioid use disorder, are regularly encountered.

#### Mental Health: Domiciliary (DRRTP)

Type: Selected Required Block or Elective

Preceptor(s): Shannon Gilhooley, PharmD, BCPS, BCPP

<u>Description:</u> Mental Health Residential Treatment Program (MHRRTP) provides residential level of care through a voluntary inpatient admission for patients to receive intensive treatment. During this rotation, the resident will work as part of the DRRTP treatment team. This program serves to provide each Veteran with the support needed to develop skills to return to independent community living and employment. The focus of this rotation will be the treatment of mental health conditions that may interfere with the Veteran's successful integration back into the workforce and independent living (including PTSD, SUD, Major Depression, Bipolar Disorder, and others).

#### Mental Health: Outpatient Substance Use Disorder Clinic

<u>Type:</u> Selected Required Block or Elective

Preceptor(s): Rashondra Levarity, PharmD, BCPP

<u>Description:</u> The Outpatient Substance Abuse Treatment Program (SATP) is a specialty clinic within the Mental Health Service. The pharmacy resident will receive experience in the treatment of Substance Use Disorder (SUD) specifically Opioid Use Disorder (OUD) and Alcohol Use disorder (AUD). The resident will be given the support to learn how to effectively manage and counsel patients on Medication Assistance Therapy (MAT) for OUD and AUD. The pharmacy resident will gain experience in working on an interdisciplinary team, motivational interviewing, review medication adherence and safety, and urine drug screen monitoring.

#### Mental Health: Outpatient Mental Health Clinic

<u>Type:</u> Selected Required Block or Elective

Preceptor(s): Kevin Thomas, PharmD, BCPP

<u>Description:</u> The outpatient Mental Health Clinic is a specialized mental health service to help with evaluation and management of the mental health needs of veterans who require a higher level of care than can be provided by PACT/PC-MHI that might not meet criteria or declined other MH services (i.e. SATP, PTSD). In that regard our population typically has a psychiatric history of schizophrenia, bipolar disorder, depression, PTSD, or complicated insomnia. The Mental Health Clinic at CWY is organized into 3 interdisciplinary teams consisting of psychiatrists, social workers, psychologists, nurses, a pharmacist, a peer support specialist and a marriage and family therapist.

During this rotation, the resident will work with BHIP teams to identify and address high risk patients as well as potential psychotropic safety concerns to assist in optimizing care. They will gain experience in dashboard management, therapeutic monitoring for patients prescribed clozapine, addressing and/or triaging medication-related problems, and enhancing their knowledge of psychiatric disease states and medications.

#### Anticoagulation Clinic

Type: Required Block Elective

Preceptor(s): Laura Vinieratos, PharmD, BCACP

<u>Description</u>: Residents will gain experience developing and implementing pharmacotherapeutic plans for patients prescribed warfarin, direct oral anticoagulants, and parenteral anticoagulant through a primarily telephone-based clinic. Residents will also get the opportunity to assist in anticoagulation management in the inpatient setting.

#### Drug Information

Type: Core Longitudinal

Preceptor(s): varies based on preceptor availability

<u>Description</u>: Residents will gain experience providing clinically accurate, concise, and timely responses to clinical staff, patients, and the community upon request and to work in concert with them to resolve problems related to drug therapy.

#### Inpatient and Outpatient Operations/Staffing

Type: Core Longitudinal

<u>Preceptor(s)</u>: Kristina Freed, PharmD, BCPS; Mandy Wortock, PharmD, BCPS; Adam McGehee, PharmD <u>Description</u>: Residents will gain experience processing and verifying inpatient and outpatient orders, answering phone calls (troubleshooting and answering drug information questions), checking IV admixtures and unit dose orders for accuracy, supervising pharmacy students (as available) and pharmacy technicians.

#### **Medication Use Evaluation**

Type: Core Longitudinal

Preceptor(s): varies based on project selection and preceptor availability

<u>Description</u>: Residents will gain experience in completing a practice-related project of publishable quality. The intent of the residency project is to provide the resident with the opportunity to develop the skills and processes necessary to perform research or to conduct a quality improvement project. Residents will be involved in literature review, project design, data gathering, statistical evaluation, writing, and reporting of their project.

#### Major Research Project

Type: Core Longitudinal

Preceptor(s): varies based on project selection and preceptor availability

<u>Description</u>: Residents will gain experience in completing a practice-related project of publishable quality. The intent of the residency project is to provide the resident with the opportunity to develop the skills and processes necessary to perform research or to conduct a quality improvement project. Residents will be involved in literature review, project design, data gathering, statistical evaluation, writing, and reporting of their project.

#### Infectious Disease

Type: Elective Block

Preceptor(s): Joseph Hong, PharmD

<u>Description</u>: Residents will gain experience practicing collaboratively with physicians and mid-level providers to provide optimal medication therapy management for patients seen in the Infectious Disease (ID) Clinic and offer services requiring the expertise of the ID inpatient consult team, antimicrobial stewardship program (ASP) champion, or other healthcare practitioner. If interested in additional experience in hepatology clinic (precepted by Dr. Ming Chow) this can be incorporated into the elective experience.

#### Advanced Infectious Disease

#### Type: Elective Block

#### Preceptor(s): Joseph Hong, PharmD

<u>Description</u>: This rotation expands upon knowledge and skills learned from the Infectious Disease rotation, with a focus on multidisciplinary care. The resident will participate in critical care team rounds, work with the emergency department healthcare team, evaluate antimicrobial therapy across a wide range of inpatient settings, seek opportunities for optimizing antimicrobial regimens, and assist with the management of infectious diseases in the critical care and emergency department settings.

#### Ambulatory Care Community Based Outpatient Clinic (CBOC)

#### Type: Elective Block

Preceptor(s): Jessica Brinks; Timothy Ebert; Jordan Lund; Jessica Natali

<u>Description:</u> This learning experience is conducted at Community Based Outpatient Clinics (CBOC) that are significant distances away from the main hospital which presents unique experiences. The majority of the experience is focused on primary clinics that are managed by Clinical Pharmacy Practitioners (CPP). The CPP in primary care is responsible for managing chronic diseases including but not limited to hypertension, hyperlipidemia, congestive heart failure, diabetes, chronic obstructive pulmonary disease, and hypothyroidism. Additional responsibilities include completing prior authorization drug reviews, drug information inquiries from the CBOC staff, and participating in team huddles. Due to the distance from the main hospital, this learning experience may also include utilization of the Heritage program for urgent, same day prescriptions and a higher level of care coordination with community providers.

#### Inpatient and Ambulatory Surgery

Type: Elective Block

#### Preceptor(s): Catherine Sypniewski, PharmD

<u>Description</u>: The acute care/surgical clinical pharmacy specialist (CPS) works with all surgical teams and is responsible for rounding with surgery teams, parenteral nutrition management, pharmacokinetic management, transitions of care for ambulatory care sensitive conditions, renal dosing, therapeutic drug monitoring, antimicrobial stewardship, IV to PO conversions, inpatient formulary management, and various other clinical interventions.

#### Pain Management, Opioid Safety, and PDMP (PMOP)

#### Type: Elective Block

#### Preceptor(s): Clara Rances, PharmD, BCPS

<u>Description</u>: Residents will gain experience coordinating pain-related facility operations and performance improvement activities and facilitating resolutions to metric driven data. The resident will gain exposure to facility management processes and metrics across areas including pharmacy pain management, facility pain operations, hospital wide opioid education and overdose prevention, federal and state laws and regulations relating to opioid safety, as well as staff development and education.

#### Cardiology

#### Type: Elective Block

Preceptor(s): Michelle Pike, PharmD, BCCP

<u>Description</u>: Residents will gain experience providing evidence-based recommendations to cardiology providers as well as implementing evidence-based pharmacotherapy optimizations within a pharmacist-led outpatient cardiology clinic. The cardiology clinical pharmacist practitioner (CPP) performs medication reconciliation of cardiovascular medications; evaluates patient specific parameters (labs, vitals, volume status, intake/output), identifies and resolves medication related issues, manages formulary and cost mitigation strategies, and supervises pharmacy residents/students. The cardiology CPP works independently in a heart failure medication titration clinic to optimize medication regimens and improve quality metrics.

#### Long Term Care Geriatrics

#### Type: Elective Block

<u>Preceptor(s):</u> Lily Truong, PharmD

Description: The purpose of this rotation is to engage the pharmacy resident in a variety of learning opportunities to expand their pharmaceutical knowledge, while continuing to develop interprofessional and patient care skills. The pharmacy resident will gain experience in comprehensive disease state management, anticoagulation therapy, antimicrobial stewardship, pain management, pharmacokinetics, total parenteral nutrition, and medication reconciliation with an emphasis on appropriate medications for a high-risk geriatric patient population and an application of the American Geriatric Society Beers Criteria. As a CLC Pharmacist, the pharmacy resident will act as a drug information resource offering counsel to healthcare providers, patients, and their caregivers. In this setting, the pharmacy resident has the opportunity to develop effective communication skills, build rapport, and foster growth of clinical confidence by collaborating with the interdisciplinary teams and building meaningful relationships with our long term care Veterans.

#### Women's Clinic

<u>Description</u>: Residents will gain experience working within the Women's Clinic PACT Team which consists of the primary care provider, nurse care manager, RN, administrative associate, social worker, and clinical pharmacist who in collaboration provide health care to women veterans. Throughout the rotation, the resident will participate in disease state management, non-formulary medication requests, and electronic consult requests.

Home Based Primary Care
