Our pharmacy residency programs build on Pharm.D. education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients with a wide range of conditions, eligible for board certification, PGY2 residencies or fellowship, and eventual clinical positions.

Stipend/Benefits

- 2023-2024 PGY-1 stipend \$47,397
- 2023-2024 PGY-2 stipend \$50,679
- In addition, this VA program supports a Dual appointment, which allows residents, once licensed as pharmacists, to get paid as pharmacists while completing some of the staffing requirements.
- Benefits include 13 vacation days, 11 paid federal holidays, sick leave, paid time to attend state/national meetings, and a health care benefit package.
