# Residency Overview

The PGY2 Cardiology Pharmacy Residency Program is a one-year post-PGY1 program with the goal of effectively preparing the resident to function as a clinical pharmacy specialist in cardiology. Specifically, the resident will be prepared for all the following: interdisciplinary (or interprofessional) cardiology focused health care, academia (adjunct or clinical faculty), and precepting (students and residents). In addition, the program is designed to provide the resident with concentrated clinical experiences with exposure to all available aspects of cardiology thereby enhancing the resident's competence and skills in patient care, and resulting in an in-depth working knowledge of cardiovascular disease management including pharmacologic and non-pharmacologic interventions.

- Satisfactory completion of a residency project including preparation of manuscript suitable for peer-review publication submission
- Preparation of a manuscript separate from PGY2 Residency Project
- Completion of BLS and ACLS Certification
- Completion of all administrative assignments (e.g., MUC, MUE, committee work) min. requirements: presentation to VISN workgroup on clinical or administrative topic, participation in facility Anticoagulation Subcommittee VISN 8 Anticoagulation and Cardiology Workgroups
