

## Required Learning Experiences

### **Acute Care I (Leavenworth)**

Residents are responsible for rounding as part of an interdisciplinary medical team. Responsibilities include medication reconciliation, discharge counseling, anticoagulation management, and therapeutic drug monitoring, among others. Areas of focus are internal medicine and infectious disease.

### **Ambulatory Care**

Residents manage patients referred to pharmacy-run anticoagulation and chronic disease management clinics. Clinical Pharmacy Specialists in these ambulatory care settings manage patients with chronic medical conditions as mid-level providers with prescriptive authority under a scope-of-practice.

### **Advanced Ambulatory Care**

Residents will build upon their initial training in ambulatory care to begin practicing precepting skills for pharmacy students. Residents will gain experience providing ambulatory care services utilizing unique modalities for providing care such as telephone care and Clinical Video Telehealth.

### **Drug Information & Teaching (Longitudinal)**

Residents are responsible for providing responses to requests for drug information from medical staff as well as developing skills in critically evaluating health related literature through projects such as journal clubs, case presentations, and in-services.

### **Geriatrics/Long-term Care**


Residents learn therapeutics in geriatric patients in the Community Living Center (a nursing home setting) and for patients in the Home Based Primary Care program. Responsibilities include medication management, drug information, coordination of care, interdisciplinary team meetings, and medication therapy reviews.

### **General Psychiatry**

Residents work collaboratively with an interdisciplinary team to provide care to patients with behavioral health disorders. Residents will gain clinical experience in psychiatric pharmacotherapy through rounding, participating in the interdisciplinary team and leading patient group discussions.

### **Administration & Leadership**

Residents develop both leadership and management skills to support the use of cost-effective medication therapy and improvement of clinical services through completion of pharmacoeconomic/practice management projects and the Leadership Development Topic Discussion Series.

The pharmacy residency program at the VA Eastern Kansas Health Care System (VAEKHCS) is an ASHP accredited training program. It is located at the Colmery-O'Neil VA Medical Center in Topeka, KS, with some experiences at the Dwight D. Eisenhower VA Medical Center in Leavenworth, KS.

This post-graduate year one residency program is designed to develop practitioners with the knowledge, skills, and abilities required of a successful clinical pharmacist. Graduates of the program are well prepared to pursue positions in clinical practice, academia, or PGY-2 residency programs.
