VANJHCS Residency Overview

Our program has a strong focus on ambulatory care pharmacy practice with many of the clinical pharmacy specialists that serve as preceptors having a scope of practice with prescribing privileges. The resident will have the opportunity to rotate through many of the pharmacist-run clinics including primary care, infectious diseases, and anticoagulation.

The program is designed to strengthen the residents' skills in direct patient care, medication management, clinical pharmacy practice, and leadership. Residents will develop the clinical and communication skills needed to provide direct patient care.

As an integral member of interdisciplinary patient care teams, residents will use their drug therapy expertise and clinical judgment to improve patient outcomes. Building on the Doctor of Pharmacy (Pharm.D.) education, learning experiences will develop well-rounded pharmacists with skills in critical thinking, project management, leadership, and oral and written communication.



VA New Jersey HCS

The VANJHCS is an integrated system consisting of two Veterans Health Affairs campuses located in East Orange and Lyons and ten Community Based Outpatient Clinics (CBOCs) located throughout northern and central New Jersey. We serve more than 56,000 Veterans with an average of 630,000 outpatient visits and 5,200 inpatient admissions per year.

The East Orange Campus is a tertiary care teaching facility affiliated with the Rutgers-New Jersey Medical Schools. It is located on 34 acres in northeast New Jersey adjacent to the City of Newark. The Campus overlooks a residential area with the Manhattan skyline visible on the horizon.
