VA Northeast Ohio Healthcare System - PGY2 Infectious Diseases Pharmacy Residency

The VA Northeast Ohio Healthcare System is a teaching healthcare system with 18 locations in Northeast Ohio that serves more than 110,900 Veterans across 21 counties. It is a training environment for more than 3,000 students across various disciplines in affiliation with more than 200 academic institutions. The main medical center, the Louis Stokes Cleveland VA Medical Center, is one of the largest VA facilities in the country and serves as the primary residency site. It is located about six miles east of downtown Cleveland at Wade Park in University Circle.



PGY2 Program Purpose: PGY2 residency programs build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

The residency program offers unique experiences to develop the knowledge and clinical skills to practice in infectious diseases, antimicrobial stewardship, HIV, and HCV. The resident will function as a member of the multidisciplinary infectious diseases team within the inpatient and outpatient setting. Our goal is to promote individual growth, professional development, self-reliance, and responsibility by developing an autonomous clinical practitioner. The program will prepare the resident to serve as a clinical pharmacy specialist in a variety of specialty infectious disease settings including academia.

SPECIAL REQUIREMENTS FOR ACCEPTANCE:

U.S. citizenship required for VA employment. Application should include curriculum vitae, letter of intent, and transcript confirming completion of Doctorate of Pharmacy coursework and degree. Letter of intent should focus on why candidate is specifically interested in the VA Northeast Ohio Healthcare System PGY2 Infectious Diseases residency program. Three references are requested, with one being from the PGY1 Residency Program Director and at least one from a clinical rotation preceptors. References should use the PhORCAS reference format (separate narrative letter not required) and should specifically comment on how the resident compares to other residents.
