




About the VA...

The Fayetteville VA Medical Center is a Clinical Core Level III facility, with 90 general medical, surgical and mental health beds, and a 69-bed long-term care unit. Fayetteville is located in southeastern North Carolina in an area populated by more than 155,000 veterans in 21 counties. The facility has three community-based outpatient clinics located in Jacksonville, Wilmington, and Hamlet, North Carolina.

The medical center has a full array of inpatient and outpatient services utilizing the latest medical technology. Veterans requiring specialized services not available at Fayetteville are referred to the Durham VAMC, or other VA facilities within VISN 6. The medical center has affiliation agreements with several educational institutions covering 24 different areas of study. These include the Schools of Pharmacy at Campbell, UNC, and Wingate.

About Fayetteville...

Fayetteville, NC is a progressive metropolitan city with a diverse friendly population, located in S.E. NC along the I-95 corridor. It is 1.5 hours from superb beaches, 3-4 hours from mountains and skiing resorts, and 1 hour from the capital city of Raleigh. 

ABOUT THE RESIDENCY...

Overview

This program is ASHP accredited. There are two PGY1 residency positions available.

Pharmacy residents are based at the Fayetteville VAMC in Fayetteville, NC. We offer a customized experience for the selected residents. There are learning opportunities scheduled in geriatrics, psychiatry, inpatient medicine, and ambulatory care, as well a resident-run clinic treating diabetics and patients with hyperlipidemia.

Various other disease state management opportunities are available to include anticoagulation, diabetes, hypertension, dyslipidemia, and smoking cessation. Other opportunities such as pediatrics are available via site sharing.

Salary & Benefits

The annual stipend is approximately \$45,000. Benefits include accrued annual and sick leave (13 days each), 10 paid federal holidays, and a health care benefits package. Full funding for conferences such as ASHP Midyear and SERC is provided (registration, lodging, and travel). The residents' large, dedicated workroom provides a quiet, personal workspace with refrigerator and microwave.
