Program Description and Goal

The Veterans Affairs Healthcare System (VAHCS) in West Palm Beach offers **the FIRST** ASHP accredited PGY2 Pharmacy Residency in Pain Management and Palliative Care as a one year post PGY1 pharmacy residency program designed to provide the resident with advanced knowledge, expertise, common skills, and abilities required to provide pain management and palliative care. It also provides exposure to the development of pain related policies within the Department of Veterans Affairs ensuring safe opioid use. The ultimate goal of the program is to enhance the resident's competence and skills as a productive member of the interdisciplinary health care team in the areas of chronic pain management, substance use disorder, hospice/palliative care, acute pain management, pain stewardship and upon graduation obtain a pain and/or palliative care clinical pharmacist practitioner position.

Required Longitudinal Learning Experiences

- Chronic Pain and Comprehensive Addiction and Recovery (CARA) Outpatient Clinic (6 months, 8 hours per week)
- Interprofessional Palliative & Hospice Care (6 months, 8 hours per week)
- Program Administration (12 months, 2 hours per week)
- Residency Project (12 months, 2-4 weeks ungraded + 2 hours per week)

Required Learning Experiences

- Acute Pain Management and Opioid Stewardship (5 weeks)
- Chronic Pain Clinic Level I (4 weeks)
- Chronic Pain Clinic Level II (4 weeks)
- Hospice and Palliative Care Level I (4 weeks)
- Hospice and Palliative Care Level II (4 weeks)
- Orientation (2-3 weeks)
- Physical Medicine & Rehabilitation (PM&R) and Pain eConsult (4 weeks)
- Substance Use Disorder & Psychiatry (4 weeks)

Role of the Resident

The resident will work as an active member of this interdisciplinary team and will gain experience in all aspects of pain management, palliative care, substance use disorder including Whole Health approaches for patient-centered care. In addition the resident will precept pharmacy students (local colleges of pharmacy) and PGY1 residents.

- Interview with formal 20-minute clinical presentation
- Graduate of ACPE approved college of pharmacy with Doctor of Pharmacy degree completion of an ASHP-accredited PGY1 pharmacy residency or one in the ASHP accreditation process
- U.S. Citizenship and licensure as a registered pharmacist in any state in the United States or Puerto Rico is required
