### **About Us**

The South Texas Veterans Health Care System (STVHCS) is comprised of two inpatient campuses: the Audie L. Murphy Memorial Veterans Hospital in San Antonio, TX and the Kerrville VA Hospital in Kerrville, TX. STVHCS provides health care services for over 100,000 Veterans. The Audie L. Murphy Memorial Veterans Hospital (ALMMVH) is a quaternary care facility affiliated with the University of Texas Health Science Center at San Antonio (UTHSCSA). Comprehensive health care is provided through acute medical, surgical, mental health, physical medicine and rehabilitation, geriatric, and primary care services in addition to care provided in the Spinal Cord Injury Center, Community Living Center (CLC), Domiciliary, and Substance Abuse Residential Rehabilitation Treatment Program (SARRTP). As a Level II Research facility, ALMMVH has projects that include aging, cardiac surgery, cancer, diabetes, and HIV. The facility has one of three National Institutes of Health sponsored clinical research centers in the VA. In addition, the Geriatric Research, Education & Clinical Center (GRECC) is a "Center of Excellence." The Pharmacy Service offers 24-hour coverage, centralized unit-dose drug distribution, a complete IV-admixture program, and clinical services across many specialties and levels of care. Outpatient pharmacies are also located in some clinics and operate during clinic business hours. The Clinical Pharmacy Program employs over 110 clinical pharmacy specialists.

- Doctor of Pharmacy degree from an ACPEaccredited institution
- Eligible to practice pharmacy in at least one statelicensure in TX is required for off-site elective rotations
