ABOUT THE FACILITY

The Charlie Norwood VA Medical Center (CNVAMC) is a level-1b healthcare system that provides care in medicine, surgery, psychiatry, rehabilitation medicine, and spinal cord injury (SCI) to our nation's Veterans.

The Downtown Division is authorized 156 beds for acute care and SCI and the Uptown Division (located three miles away) is authorized 93 beds for psychiatry and rehabilitation services, 132 beds for Nursing Home Care Unit, and a 60-bed Domiciliary.

CNVAMC also has teaching affiliations with Augusta University allowing for training collaborations.

Located in Augusta, GA, CNVAMC is home to The Masters and centrally located between multiple dynamic cities including Atlanta, Charlotte, Charleston, and Savannah. Also, Augusta is only a couple hours from the beach and the mountains.
