## About the Facility

Harry S. Truman Memorial Veterans' Hospital is a level 1c facility with 130 inpatient operating beds. Staff at the medical center provide a full continuum of care in both inpatient and outpatient settings, and are committed to excellent patient care, education, and research. The facility offers comprehensive care to include primary care, medical and surgical specialties, behavioral health, physical and occupational therapy, and pharmacy services. In addition, Truman VA is a referral center for heart care services to include open heart surgery. The facility also offers additional services such as audiology and speech pathology, social work, dermatology, dental, neurology, oncology, orthopedic surgery, podiatry, prosthetics, urology, vision care, cardiology, endocrinology, and rheumatology.

Truman VA maintains strong affiliations with the University of Missouri's School of Medicine, the MU Sinclair School of Nursing, the MU School of Health Professions, and other health-related programs. Truman VA provides training opportunities for approximately 900 students each year.

## About the Program

The PGY1 Pharmacy Residency is new to Truman VA and currently in candidate status with ASHP with accreditation survey planned for April 2023. The Pharmacy Service employs 44 pharmacists, including 14 Clinical Pharmacist Practitioners.


PGY1 pharmacy residency programs build on Doctor of Pharmacy (Pharm.D.) education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients with a wide range of conditions, eligible for board certification, and eligible for postgraduate year two (PGY2) pharmacy residency training.
