The Curriculum

The pharmacy resident will be based at the Fayetteville Health Care Center in Fayetteville, NC. The HCC is a brand new state-of-the-art outpatient facility and will house our PACT clinics, diabetes clinic, outpatient pharmacy, and other ambulatory care services.

We offer a customized experience for the selected resident. The resident will co-manage a PACT team in primary care, as well as be involved in other ambulatory care experiences. Various disease state management opportunities are available to include anticoagulation, diabetes, hypertension, and dyslipidemia. Other opportunities are available based on resident interests.
