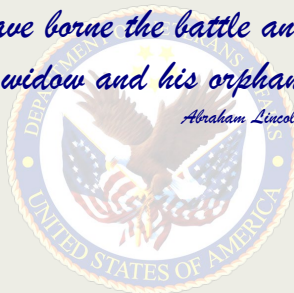

PROGRAM DESCRIPTION

The VA Sierra Nevada Health Care System offers a one year, ASHP-accredited PGY2 residency in Geriatric Pharmacy. Our goal is to produce highly skilled geriatric clinical pharmacy specialists that are able to excel in various advanced practice settings and have the capabilities to show leadership in their future practice site and profession. Completion of the residency prepares its graduates to assume positions in geriatric patient care, academia, or other specialized positions, especially within in the VA setting and will be well prepared to pursue board certification in geriatric pharmacy.

The resident will develop these skills through participation in rotations, electives, and experiences including but not limited to:

- ◆ Community Living Center (CLC)
- ◆ Home-Based Primary Care (HBPC)
- ◆ Hospice and Palliative Care
- ◆ Inpatient Mental Health
- ◆ Geriatric Ambulatory Care
- ◆ Pharmacoeconomics
- ◆ Pain Management
- ◆ Community Nursing Home Care
- ◆ Teaching Certificate available if not obtained as a PGY1

The resident will have the opportunity to precept pharmacy students and PGY1 residents. In addition, the resident will participate in the completion of a formal residency project.

Other residencies affiliated with this program include

- ◆ ASHP Accredited PGY1 Pharmacy Residency, including Rural Health
- ◆ ASHP Accredited Pharmacy Outcomes and Healthcare Analytics (PGY2)
- ◆ ASHP Accredited Psychiatric (PGY2)

The Geriatric Pharmacy PGY2 offers a **pre-commitment** option for those completing a PGY1 residency at the VASNHCS.

ABOUT THE VA SIERRA NEVADA HCS

The VA Sierra Nevada Health Care System (VASNHCS) provides a wide array of inpatient and outpatient services. Our care extends beyond the Reno metropolitan area with community based outpatient clinics (CBOCs) in Auburn (CA), Fallon, Gardnerville, and Susanville as well as a rural outreach clinic in Winnemucca.

The Ioannis A. Lougaris Medical Center in Reno, Nevada is the primary facility where residents train. The medical center provides care to over 32,000 veterans in Northern Nevada, Southern Oregon and Northeast California. This 124-bed primary care hospital is affiliated with the University of Nevada, Reno (UNR) School of Medicine, the Idaho State University School of Pharmacy, and the Roseman University of Health Sciences. There is also an on-site 60-bed Community Living Center, a skilled nursing facility for veterans with subacute, chronic, and hospice & palliative care needs.

The hospital is located near Lake Tahoe, the Sierra Nevada mountains, and world-class winter sports. Reno offers an ideal climate for outdoor activities, many entertainment opportunities, and San Francisco,

Napa Valley, and Yosemite are within a four-hour drive.

The progressive Pharmacy Service consists of 50+ full-time pharmacists. Formal educational programs are offered for pharmacy residents and PharmD students, medical residents and students in psychiatry, internal medicine, family practice, and surgery as well as medical fellows in geriatrics and hospice & palliative care.

In the geriatric setting, pharmacists work under an expanded scope of practice in a mutually respectful and collaborative environment, with the shared goal of best patient outcomes.

Pharmacists working in primary care and specialty areas also function as providers under scope of practice. Inpatient pharmacists are actively involved in patient care as well. High levels of technician support, state-of-the-art robotics, and electronic order entry facilitates the high level of clinical services provided throughout the VASNHCS.
