Upload the following items to PhORCAS by the deadline (**January 6, 2017**)

- ✓ **Letter of intent including dates you are available for interview in January and February**
- ✓ **Current Curriculum Vitae**
- ✓ **Request three letters of recommendation** to be submitted on the Standard Applicant Recommendation Request Form with a detailed recommendation (PhORCAS). At least two should be from clinical preceptors (due by January 15).
- ✓ **Request official copies of your college of pharmacy transcript**, along with other transcripts of all colleges attended, to be forwarded to PhORCAS as instructed on the website
- ✓ **Documentation of United States citizenship** (upload scanned passport page, birth certificate or naturalization papers)—supplemental requirement
- ✓ **Completed Pharmacy Practice Pre-Training Assessment in narrative format** — supplemental requirement

It offers a home care program and has a large ambulatory practice with 250,000 annual patient visits.

You will work side by side with our clinical practice pharmacists in our Anticoagulation, Lipid, Chemotherapy, Diabetes, Hepatitis C/HIV, Geriatrics, and PACT Medication Management clinics. Our inpatient clinical specialists practice in the Critical Care, Acute Care and Geriatrics patient care centers. Many of our staff members have completed residencies and are Board Certified.
