Qualifications of the Applicant:

The Applicant must be a graduate of a school of pharmacy accredited by the American Council on Pharmaceutical Education (ACPE), be a U.S. citizen, possess the Doctor of Pharmacy degree, and be licensed in at least one state, the District of Columbia, or territory of the United States. The applicant must have graduated with a minimum 3.0 GPA, or have completed a minimum 3 years experience in pharmacy practice.

The applicant must demonstrate excellence throughout their academic or professional career, with a desire to succeed in a challenging and innovative pharmacy practice environment. The applicant must possess excellent communication skills, aptitude for leadership, and strong work ethic. The applicant must be dependable, reliable, and able to adapt to different work environments with both pharmacy and other healthcare providers.

These qualities will be judged through interviews, pharmacy school transcripts, and letters of recommendation as provided through the application process.

Selection of the Applicant:

Selection of the applicants for the PGY-1 positions will be made by the pharmacy residency selection committee at the Mann-Grandstaff VA Medical Center with direct oversight from the Chief of Pharmacy Services and the Residency Program Director.

Interested applicants must participate in the ASHP Residency Matching Program (The Match) and the Pharmacy Online Residency Centralized Application Service (PhORCAS).

After review of all applicants, selected applicants will be invited for an interview.
